This analytical review aims to present the book 'Consolidação, Simplificação e Revisão do Arco Normativo Infralegal da Saúde: um projeto, muitas vozes' (1), launched on March 20, 2024, during the Assembly of the National Council of Health Secretaries (Conass). The book represents the biographical history of a pioneering and innovative project to consolidate the infralegal regulatory framework of the Unified Health System (SUS).

Organized by Alethele Santos, Márcio Aranha, Maria Célia Delduque and Sandra Alves, this book is constructed in straightforward narrative language and creative illustrations. It describes, in chronological order, the formulation and development of the project in three stages, highlighting the technical arrangements, political and legal frameworks adopted, as well as the facilities and difficulties faced over the course of more than two years. The speeches and testimonies of the project participants are also highlighted, in a necessary acknowledgment of the work of each collaborating professional who brought the project to fruition and made this extremely important regulatory milestone happen.

The book is divided into three chapters. The first, "Every journey begins with the first steps", recounts the SusLegis-1 project, the birthplace of all the work to organize and give legality to the huge and complex constellation of ordinances issued by the health minister's office, the so-called GM Ordinances. This chapter should be read several times, because in addition to the lightness of the text, interspersed with highlights of the collaborators' speeches, it guides the reader through the successive chronologically organized stages in the construction of the projects.

In Chapter 2, entitled "SusLegis-2: the second phase will be easier, but not that easy!", the authors humorously describe the most complex regulatory organization project ever carried out in Brazil's republican history. The chapter reports on the training experience, carried out in partnership with the University of Brasilia, which taught SUS operators from all over Brazil how to handle the Consolidation Ordinances published at the time in the Federal Official Gazette and then in force. The illustrations speak for themselves!

The third and final chapter, entitled "Legisus: the possible, the impossible and the unthinkable", brilliantly closes the book, discusses the completion of the projects and the success that accompanies them to this day, and also points to the future, projecting the wish that, perhaps, the Brazilian authorities will always be careful with the normative organization that gives legal support to our SUS.

In addition to these accounts, the book pays posthumous tribute to two of the project's most important collaborators: Lourdes Almeida and Luiz Carlos Pelizari Romero.

By the end of the text, the reader will have a clear understanding of its title, as it aptly illustrates the collective construction of the project, considering the many voices that took part in the three stages and that narrate this story, and in fact constitute the driving forces behind this achievement.

From what has been said so far in this review, which is only a glimpse of the whole, we recommend reading it without regret to anyone who is directly or indirectly involved in the country's health sector and to anyone who enjoys a good, well-told story.
