Abstract

The relationship between Law and Health is becoming increasingly complex, given the growing challenge of ensuring fundamental rights amid the various transformations that influence the global health landscape. In this context, Health Law emerges as an essential field of knowledge to address the legal aspects of health protection and the regulation of new practices and services, ensuring a balance between globalization, innovation, and the protection of human rights. The current issue of the Cadernos Ibero-Americanos de Direito Sanitário presents a set of articles developed to engage with the central theme of the Congreso Internacional de Derecho Sanitario, a result of the collaboration between the University of Granada, Spain; the National University of Distance Education, Spain; and the Health Law Program of the Oswaldo Cruz Foundation, Brazil.

The relationship between law and health is becoming increasingly complex due to the growing challenge of guaranteeing fundamental rights in the face of technological, political, social and economic transformations that influence the global health landscape.

Access to new technologies and innovation processes, the circulation of knowledge and information and the strengthening of cooperation in health are examples of the positive effects of globalization on health. On the other hand, the spread of infectious diseases, the protection of the health of refugees and undocumented immigrants and unequal access to health services are some of the challenges imposed by this same scenario.

This paradoxical relationship requires States to adapt their public health policies so that the benefits are widely distributed and the challenges are adequately managed, reducing vulnerabilities.

In this context, Health Law becomes an essential field of knowledge to address the legal aspects of health protection and the regulation of new practices and services, ensuring a balance between globalization, innovation and the protection of human rights. To this end, training in the area, aimed at both health and legal professionals, in which the development of legal-political-health competencies to address health issues and their intersections is encouraged, should be the object of attention by States and their educational and research institutions.

The Congreso Internacional de Derecho Sanitario⁽¹⁾, attentive to global transformations and their repercussions on the Right to Health, has chosen as the central theme of the event 'Training in Law and Health in the face of the new challenges of the 21st Century'. Organized through a collaboration between two major teaching institutions in Spain - the University of Granada and the National University of Distance Education - and the Health Law Program of the Oswaldo Cruz Foundation of Brazil, the event brought together specialists and academics from various fields, who focused on sensitive issues for Health Law and which represent challenges for countries and their health systems.

This edition of the Cadernos Iberomericanos de Dereito Sanitario (CIADS) has been specially designed to bring together articles by some of these researchers and scholars, who, by accepting the invitation, contribute to the development of Health Law by highlighting its relevant role in the contemporary challenges of a digitally globalized world.

And it is in this spirit of international collaboration that we present to the readers of CIADS this unpublished edition which, we hope, will be a valuable source of information, reflection and development of Health Law, contributing to the advancement of regulations and practices that promote fairer health.
